

TERMS AND CONDITIONS OF LEGO® LNY 2026 GOLD RUSH DAILY LUCKY DRAW

(The “Contest”)

A. ELIGIBILITY

- Participation in this contest is deemed acceptance of these Terms and Conditions. Each Participant also consents to the use by the LEGO® Group of his or her personal information for feedback, promotional and marketing purposes.
