

Spot Stellect Around Singapore 2026 Terms and Conditions

A. General

1. The EssilorLuxottica “Spot Stellect Around Singapore Campaign 2026” (“the **Promotion**”) is organized by ESSILORLUXOTTICA ASIA PACIFIC PTE. LTD (“the **Organiser**”).
2. The Promotion entitles a customer to participate in Spot Stellect Around Singapore Lucky Draw (“the **Offer**”).
3. The Promotion shall commence from **1 July 2026** and will run until **31 August 2026** (“**Promotion Period**”). Notwithstanding the Campaign Period, entries submitted in relation to eligible purchases of Essilor® Stellect® lenses made between **1 June 2026 and 31 August 2026** (both dates inclusive) shall qualify for participation in the Promotion, subject to these Terms and Conditions. The Organiser reserves the right at any time to modify or discontinue temporarily or permanently, this Promotion without prior notice for any reason whatsoever. All purchases of Eligible Lenses outside the designated Promotion Period will not be eligible for the promotional offer. The Promotion Period and all other terms and conditions are subject to be changed by the Organiser without prior notice.
4. The Promotion is subject to the terms and conditions stated herein and the Organiser reserves the right to vary, add, modify and/or alter these terms and conditions as and when it deems fit. If the performance of the Organiser in respect of the Promotion is prevented or delayed due to circumstances beyond the control of the Organiser, including force majeure conditions, the Organiser shall not be liable for the consequences of such non-performance.
5. The Organiser reserves the right to disqualify the customer from the Promotion if any fraudulent activity is identified as being carried out for the purpose of availing the benefits under this Promotion.

1. Customer will need to take photo or screenshot of the advertisement and submit them on the portal, essilor-rewards.com.
2. There will be a total of **two (2) lucky draws** (3 August 2026, 1 September 2026) conducted during the Promotion.

a. First Draw

- Entry submission period: 1 June 2026 to 31 July 2026 (both dates inclusive)
- Draw date and winner announcement: 3 August 2026
- Ten (10) winners will be selected.

b. Second Draw

- Entry submission period: 1 August 2026 to 31 August 2026 (both dates inclusive)
- Draw date and winner announcement: 1 September 2026
- Ten (10) winners will be selected.

A total of **twenty (20) winners** will be selected throughout the Promotion, with each winner receiving one (1) **myFirstFone R2 Watch**.

3. Non-winning entries from each draw will automatically remain eligible for subsequent lucky draws conducted during the promotion period, provided such entries continue to comply with these Terms and Conditions. Winning entries will not be eligible for subsequent draws.
